Key changes to Insurance Council Board

The Board of the Insurance Council of Australia (ICA) has made several new appointments following a Special Board Meeting held in Sydney yesterday.

- Mr Anthony Day, Chief Executive Officer Insurance, Suncorp, has been appointed President of the Insurance Council and Chairman of the Board
- Mr Richard Enthoven, Chief Executive Officer, The Hollard Insurance Company, has been appointed Deputy President
- Mr Patrick Regan, Group Chief Financial Officer and Chief Executive Officer, Australian & New Zealand Operations, QBE, has joined the Board as a Director

The Managing Director of Allianz Australia Insurance, Mr Niran Peiris, has stepped down as Acting President and as Deputy President. He remains a director.

ICA CEO Rob Whelan said Mr Day and Mr Enthoven brought strong industry experience to the Board's leadership for their two-year terms.
